2 Overview

2.1 SASStk – Slackware Administrators Security tool kit

The SASStk scripts will run through and ask about all of the services and daemons you wish to disable or enable. It will put your box in a reasonably secure state in the fact that you will be presented with info about all services and can disable all of them.

We added support for other security aspects such as password aging and similar configuration for the machine.

2.2 SASrc – Slackware Administrators Security configuration

The SASrc scripts are the replacements for the normal Slackware `/etc/rc.d/*` files. They use an `/etc/rc.d/rc.conf` and `/etc/rc.d/rc.paths` to make it easier to turn on and off scripts.

1. Provide better documentation on services running.
2. Provide an easy to use and fast method of system administration
3. Help secure the box and educate the sysadmin at the same time

3 Install

3.1 SASTk install

Please see "NOTES" before installing.

Note: You will change to single user mode to perform the installation. While not strictly necessary, we do recommend rebooting the system after the installation and configuration is completed. There was a problem in the past with a variable being set and causing a bit of a problem. It has been fixed now and should not cause problems.

3.1.1 Installing from Slackware .tgz package

1. Login as or `su -` to root
2. We recommend you rename the `SASTk-version.tgz` file to `SASTk.tgz` this will simplify upgrading and maintenance of future packages we will assume you have done this and we now refer to the package as `SASTk.tgz`
3. `installpkg SASTk.tgz`

This will install the scripts into `/root/SASTk/` and set the correct permissions for the files to be installed.

4. `cd /root/SASTk/src/`
5. Begin the installation with:
`./install.sh`

This will install the scripts to the correct locations and then will prompt you for the configuration and hardening process.

3.1.2 Installation from source .tar.gz file

1. Login as or `su -` to root.
2. `cp SASTk-version.tar.gz /root/`
3. Extract using: `tar -zxvpf SASTk-version.tar.gz`
This will create a `/root/SASTk-version/` directory.
4. `cd /root/SASTk-version/src`
5. `chmod -R 0700 *`
6. `./install.sh`

3.1.3 Removing SASTk - source tarball

If you want to remove SASTk from your system you must keep both the `/root/SASTk-version/` files and the `/var/log/sastk` files intact.

1. Login as or `su -` to root.
2. `cd /root/SASTk-version/src/`

3. `./sastk_undo.sh`

This will ask you to boot into single user mode to complete the uninstall.

It will return your system configuration to the way it was before you installed SAStk.

4. After switching to multiuser mode, you may remove `/var/log/sastk/` and `/root/SAStk-version/` directories.

3.1.4 Removing SAStk as a slackware package:

If you want to remove SAStk from your system you must keep both the `/root/SAStk/` files and the `/var/log/sastk` files intact.

1. Login as or `su -` to root.
2. `cd /root/SAStk/src/`
3. `./sastk_undo.sh`

After switching to multiuser mode, you can remove the files by:

4. `removepkg SAStk.tgz`

3.2 SASrc install

SASrc is now part of SAStk and automatically installed with SAStk. Manual installation is possible and easy to do, however a scripted method is not going to be coded at this time since SASrc is best used with SAStk.

4 FAQ

1. Why redo slackware's initialization scripts?

Because while it works, it could be better. We think that a setup with `/etc/rc.d/rc.conf` is a faster and cleaner method. The object is to educate the user and to make it faster and easier for a new sysadmin.

2. Where's the source?

The source code is available on the CVS and FTP servers in CVS tree, tarball, shar archive, and slackware package formats.

0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other written document *free* in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondly, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.

This License is a kind of “copyleft”, which means that derivative works of the document must themselves be free in the same sense. It complements the GNU General Public License, which is a copyleft license designed for free software.

We have designed this License in order to use it for manuals for free software, because free software needs free documentation: a free program should come with manuals providing the same freedoms that the software does. But this License is not limited to software manuals; it can be used for any textual work, regardless of subject matter or whether it is published as a printed book. We recommend this License principally for works whose purpose is instruction or reference.
