


TFI serves the entire fertilizer supply chain from importers and producers to wholesalers and distributors to retailers as well as anyone providing services to the fertilizer industry.

G7 Global Partnership (GP) Chemical Security Sub-Working Group

Global Partnership Against the Spread of Weapons and Materials of Mass Destruction

- The G7 GP supports and coordinates projects and activities in chemical, biological, nuclear, and radiological security
- 31 member states plus international organizations
- CSWG focuses on efforts to counter the spread and use of chemical weapon (CW)-related chemicals and precursors, and supports initiatives that promote chemical security across industry and other relevant communities
- GP Matchmaking: Mechanism to pair chemical threat reduction proposals with GP donor funding and/or expertise



Chemical Security Government Partnerships

- U.S.-Canada Regulatory Cooperation Council is an U.S. Office of Management and Budget (OMB)/Canada Treasury Board-led initiative to eliminate unnecessary regulatory differences and promote free trade
 - CISA Chemical Security and Natural Resources Canada Work Plan on Precursor Chemical Harmonization and Collaborative Science and Technology
- Regulatory Exchanges and Dialogues with European Commission, United Kingdom, Philippines, and Singapore
