Governance

- ▶ The Governance Committee continued to develop questions for the NCSWIC Intellectual Capital Assessment and plans to finalize the survey questions during the in-person committee meeting on May 3, 2017

Charter Update Working Group

- ▶ Working group members met on April 3 and 17, 2017, to finalize updates to sections four and five of the NCSWIC Charter
- ▶ Members also met on April 24, 2017, to conduct a final review of the entire updated charter
- ▶ Members of the working group will present the suggested changes to the NCSWIC during the May 4, 2017, in person meeting with hopes of publishing the updated charter following a vote later in the month

Planning, Training, and Exercise

- ▶ The Planning, Training, and Exercise (PTE) Committee met on April 18, 2017
- ▶ The committee continued developing its Communications Unit (COMU) Personnel Position Task Book (PTB) Sign-Off Process Template
- ▶ The committee finalized its Best Practices for Developing a Field Operations Guide (FOG) Survey
- ▶ The committee discussed the potential for another in-person committee meeting in August 2017

Technology Policy (Joint with SAFECOM)

- ▶ The Technology Policy Committee met on April 18 and finalized the agenda for the May 3, 2017 in-person committee meeting
- ▶ Members continued discussions on Public Safety Grade definition and white paper and the T-Band Migration
 - The committee will continue to monitor T-Band actions and determine appropriate actions
- ▶ Committee members received updates on Federal Partnership for Interoperable Communications (FPIC) activities and initiatives including updates on FPIC's "Memorandum of Understanding (MOU)" designed to provide emergency response personnel with easier access to federal interoperability channels with UHF and VHF frequencies
- ▶ Members also reviewed and approved the Identity, Credential, and Access Management (ICAM) Working Group "Reference Guide"
- ▶ Next meeting: May 3, 2017, in San Antonio, Texas

ICAM Working Group

- ▶ The ICAM Working Group met on April 18, approved the ICAM “Reference Guide,” and researched and explored outreach options for ICAM work products
- ▶ The working group submitted the following work products to both the SAFECOM and NCSWIC Executive Committees for vote and approval:
 - Trustmark Framework Position Paper
 - Trustmark Framework Tri-fold Brochure
 - ICAM 101 Executive Briefing

Funding and Sustainment (Joint with SAFECOM)

- ▶ The Joint Funding and Sustainment Committee met on April 19, 2017
- ▶ The Committee authorized Shirrell Roberts to send the revised Project 25 (P25) Letter to his peers – State Administrative Agencies (SAA) and State Homeland Security Advisors (HSA) – to raise awareness of the importance of purchasing standards-based equipment
- ▶ Members continued discussions on estimating life cycle funding and refined the life cycle survey for distribution during the May Joint SAFECOM and NCSWIC in-person meeting working session
