PPD-21 Requirements and Scope

- Directs the Secretary of Homeland Security to provide to the President...a successor to the National Infrastructure Protection Plan to address the implementation of this directive [PPD-21], the requirements of Title II of the Homeland Security Act of 2002 as amended, and alignment with the National Preparedness Goal and System required by PPD-8.
- This effort will be coordinated with government and industry CI stakeholders to include: public and private CI owners and operators, SLTT entities, SSAs, other relevant Federal departments and agencies
- Must be completed within 240 days (by 10 Oct 2013)

Required Elements for NIPP Update

Specific to PPD-21:

- Functional relationships within DHS and across the Federal Government related to critical infrastructure security and resilience
- Protocols to synchronize communications and action within the Federal Government
- Risk Management Framework for strengthening the security and resilience of critical infrastructure
- Updates to the sector partnership model resulting from the partnership evaluation deliverable
- Metrics and analysis process to measure the Nation's ability to manage and reduce CI risks
- Alignment with National Preparedness System required by PPD-8

Key Elements for Inclusion in TOC

- Authorities
- Roles and Responsibilities
- Risk Management Framework / Risk-Based Prioritization
- Information Sharing
- Updates to the Partnership Model based on PPP Evaluation
- Accountability, Measurement, and Reporting
- Innovation – Incentives, Research and Development
- Interdependencies: Cyber-physical; PPD-8



Process for Completion

- Established a Content Development subgroup (government and industry) focused on content development for the NIPP
- Established a larger Review and Validation group to review content of the subgroup
- Participants in the process will share content broadly with their organizations, agencies, partners, academia, etc for widest distribution, comment, idea generation and awareness
- Content developed will be shared broadly through online collaboration community (<http://eoppd.ideascale.com>) for ideas and input
- Notice of Update to the NIPP published to the Federal Register on 8 June. Comments due back on 8 July. Click [Here](#) for comments.
- 2nd Federal Register notice early August
- Enters DHS and Inter Agency clearance process in September
